A1 Circuit Criminal

- Removed Appeals - Record Appeals in the filing fee line.

A3 Circuit Civil

- Removed \$80 filing fee - Record \$80 filing fee in the filing fee line.
- Removed Appeals - Record Appeals in the filing fee line.
- Removed Counter Claims - Record Counter Claims (General and Foreclosure) in the filing fee line.
- New – Foreclosures \$50k-\$250k is a new \$350 revenue. Please break out from the filing fee and record it on this new line.
- New – Issuance of a Summons is a new revenue. Please record it on this new line.

A4 County Civil

- Removed \$80 filing fee - Record \$80 filing fee in the filing fee line.

A5 Probate

- Removed \$80 filing fee - Record \$80 filing fee in the filing fee line.
- Removed Appeals - Record Appeals in the filing fee line.
- Removed Counter Claims - Record Counter Claims General in the filing fee line.
- New – Filing Fees, s. 28.2401(1), F.S. covers several fee splits previously sent to General Revenue. The FCCC Distribution Schedule identifies each fee for reference. Please record these new revenues separately on this new line in Probate.
- New – Service Charges s. 28.2401(1), F.S., is a new revenue. Please break it out from the filing fees line and record it on this new line.
- New – Issuance of a Summons is a new revenue. Please record it on this new line.

A6 Family

- Removed \$80 filing fee - Record \$80 filing fee in the filing fee line.
- Removed Appeals - Record Appeals in the filing fee line.
- Removed Counter Claims - Record Counter Claims General in the filing fee line.

CFY 2022-23 EXPENDITURE & COLLECTION REPORT CHANGES

- New – Dissolution of Marriage is a new clerk revenue. Please break it out from the service charges line and record it on this new line.
- New – Issuance of a Summons is a new revenue. Please record it on this new line.

A7 Criminal Traffic

- Removed Appeals - Record Appeals in the filing fee line.
- Removed Adjudication Withheld - Record Adjudication Withheld in the fines line.

A8 Civil Traffic

- No changes. There are new civil traffic citations; however, continue to record these fines in the broad category, as splitting these new revenues into a separate category is unnecessary.

A9 Juvenile Dependency

- Removed \$80 filing fee - Record \$80 filing fee in the filing fee line.
- Removed Appeals - Record Appeals in the filing fee line.
- Removed Counter Claims - Record Counter Claims General in the filing fee line.
- New – Issuance of a Summons is a new revenue. Please record it on this new line.

A10 Juvenile Delinquency

- Removed Appeals - Record Appeals in the filing fee line.
- Removed Adjudication Withheld - Record Adjudication Withheld in the fines line.

A11 Other Local Court Revenue

- Only use this section as a last resort. It is crucial to attempt to record the revenues in the proper court divisions to have accurate information when projecting future revenue. All previous changes are also found in this section, but avoid using this section, if possible.

Excess Revenue

- There is a new excess revenue line. Previously, excess revenue was calculated and remitted to the trust fund monthly. With the changes in HB 977, excess revenue will be calculated and remitted quarterly. The CCOC retained the 1/12th excess revenue on Line 162 for reference and created a 1/4 excess revenue cell on Line 163, highlighted in **Yellow**. We understand some clerks may wish to continue to see their excess revenue monthly; however, you are only required to remit excess funds in October, January, April, and July. As this bill section was effective July 1, the first quarterly remittance is due by October 10, 2023.
