COMMITTEE ACTION: Appoint Incoming Executive Director

OVERVIEW:

John Dew has served as the Executive Director of the CCOC since its creation in 2003. His unflinching leadership, integrity, and hard work has established the CCOC as an integral part of the clerks' family. The committee, on behalf of all clerks, would like to thank Mr. Dew for his 21 years of service and congratulate him on his well-deserved retirement.

Jason L. Welty joined the CCOC in July of 2018 as the Budget and Communications Director. Mr. Welty was promoted to Deputy Executive Director in April of 2021. In September of 2023, the CCOC Executive Council named Mr. Welty as the Designate Executive Director. In November of 2023, Mr. Welty was appointed by Governor Ron DeSantis to serve as the Jefferson County Clerk of Court.

Therefore, the committee has the opportunity to appoint Mr. Welty as Executive Director of the CCOC effective November 1st, 2024.
